CERTIFICATE OF INCORPORATION**

McJunkin Red Man Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Board of Directors of the Corporation, by unanimous consent dated September 8, 2015, unanimously adopted resolutions proposing and declaring advisable the following amendment to the Certificate of Incorporation of the Corporation:

The Certificate of Incorporation of the Corporation shall be amended to read in its entirety as follows:

"FIRST: The name of the Corporation is MRC Global (US) Inc."

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders having not less than the minimum number of votes that would be necessary to authorize or take the action described in Article First above at a meeting of the stockholders of the Corporation at which all shares entitled to vote thereon were present and voted have given written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Section 242 of the General Corporation Law of the State of Delaware.
