RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY TRADEMARKS (this "Release") is made effective as of March 30, 2016, by U.S. Bank National Association, a national banking association (the "Secured Party") for itself and as Administrative Agent for the Lenders (as defined in the Credit Agreement referenced below) in favor of Imagine! Print Solutions, LLC, a Delaware limited liability company (formerly Imagine! Print Solutions, Inc., a Minnesota corporation) ("Imagine!").

WHEREAS, Imagine!, DigiGraphics, LLC, a Minnesota limited liability company ("DigiGraphics"), Classic Graphics, LLC, a Delaware limited liability company (formerly Classic Graphics, Inc., a North Carolina corporation) ("Classic Graphics" and, together with Imagine!, and DigiGraphics each a "Borrower" and, collectively, the "Borrowers"), the Lenders, and the Secured Party, with one of the Lenders, as administrative agent for the Lenders (the "Administrative Agent"), are all parties to an Amended and Restated Credit Agreement dated December 2, 2013 (as the same has been amended, supplemented, extended, restated or otherwise modified from time to time, and including the version prior to amendment and restatement, the "Credit Agreement") pursuant to which the Lenders agreed to extend to the Borrowers certain credit accommodations;

WHEREAS, pursuant to the Credit Agreement, Imagine! executed and delivered a Confirmatory Grant of Security Interest in Intellectual Property dated July 28, 2011 (the "First Confirmatory Grant") granting the Secured Party a security interest in and lien on the trademarks identified on Exhibit A hereto;

WHEREAS, the First Confirmatory Grant was recorded with the United States Patent and Trademark Office ("PTO") against the trademarks identified on Exhibit A hereto on August 2, 2011, at Reel 4595, Frame 0404;

WHEREAS, pursuant to the Credit Agreement, Imagine! executed and delivered a Confirmatory Grant of Security Interest in Trademarks dated December 2, 2013 (the "Second Confirmatory Grant") granting the Secured Party a security interest in and lien on the trademarks identified on Exhibit B hereto (collectively, with Exhibit A, the listed trademarks are referred to hereinafter as "Trademark Collateral");

WHEREAS, the Second Confirmatory Grant was recorded with the PTO against the trademarks identified on Exhibit B hereto on December 3, 2013, at Reel 5166, Frame 0251; and

WHEREAS, Imagine! and the Borrowers have satisfied all of the obligations under the Credit Agreement and have requested that the Secured Party terminate and release its security interests in and liens on the Trademark Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

- 1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement.
- 2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the Trademark Collateral.


