**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”), dated as of April 28, 2016, is made by JPMORGAN CHASE BANK, N.A., in its capacity as Administrative Agent (the “Agent”), under that certain Amended and Restated Security Agreement, dated as of August 13, 2013 (as amended, restated, amended and restated, modified or supplemented from time to time, the “Security Agreement”), by and among Pinnacle Entertainment, Inc. (the “Grantor”), the other grantors party thereto and the Agent. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement (including by reference to other agreements).

W I T N E S S E T H

WHEREAS, in connection with the Security Agreement, (i) the Agent was assigned certain security interests previously granted by the Grantor pursuant to that certain Assignment and Assumption (Intellectual Property), effective as of August 13, 2013 (the “Assignment and Assumption”), by and among the Agent and Barclays Bank PLC, which Assignment and Assumption was recorded with the U.S. Patent and Trademark Office (“USPTO”) on August 21, 2013 at Reel/Frame Nos. 5095/0399, 5095/0532, 5095/0642, 5095/0448, 5095/0495, 5095/0558, 5095/0619, 5095/0681, 5095/0707, 5095/0732, on August 22, 2013 at Reel/Frame Nos. 5095/0966, 5096/0001, 5096/0040, 5096/0080, 5096/0200, 5096/0441, 5096/0243, 5096/0270, 5096/0298, 5109/0473, 5109/0417, 5109/0503, and on April 20, 2016 at Reel/Frame Nos. 5774/0633 and 5774/0672, (ii) Grantor and Agent entered into (a) that certain Trademark Security Agreement, dated August 13, 2013 and recorded with the USPTO on August 21, 2013 at Reel/Frame No. 5093/0119, (b) that certain Trademark Security Agreement, dated November 12, 2013 and recorded with the USPTO on November 18, 2013 at Reel/Frame No. 5156/0128, (c) that certain Trademark Security Agreement, dated March 19, 2014 and recorded with the USPTO on March 25, 2014 at Reel/Frame No. 5243/0599, (d) that certain Trademark Security Agreement, dated July 22, 2014 and recorded with the USPTO on August 4, 2014 at Reel/Frame No. 5336/0437, (e) that certain Trademark Security Agreement, dated November 3, 2014 and recorded with the USPTO on November 3, 2014 at Reel/Frame No. 5393/0406, (f) that certain Trademark Security Agreement, dated January 20, 2015 and recorded with the USPTO on January 22, 2015 at Reel/Frame No. 5445/0293, (g) that certain Trademark Security Agreement, dated May 8, 2015 and recorded with the USPTO on May 8, 2015 at Reel/Frame No. 5513/0176, (h) that certain Trademark Security Agreement, dated October 22, 2015 and recorded with the USPTO on October 26, 2015 at Reel/Frame No. 5652/0627, and (i) that certain Trademark Security Agreement, dated February 24, 2016 and recorded with the USPTO on March 1, 2016 at Reel/Frame No. 5743/0741, pursuant to which the Grantor granted to Agent a security interest in and to all of its right, title and interest in and to certain of its Trademarks (the “Trademark Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:


The Agent hereby RELEASES, without recourse, representation or warranty its security interest in all of the Trademark Collateral, including the trademark registrations and trademark applications set forth on Schedule I attached hereto and incorporated herein by reference.

This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the law of the State of New York, without regard to conflicts of law or choice of law provisions that would permit the application of the laws of any other jurisdiction (other than any mandatory provisions of the UCC relating to the law governing perfection and the effect of perfection of the security interest).
