TRADEMARK ASSIGNMENT

WHEREAS, Assignor is the owner of record of United States Trademark Registration Nos. 4,421,697 for CARS WITH HEART which covers "[c]haritable services, namely, coordination of the procurement and sale of donor vehicles for charities," in Class 35 and 4,174,483 for QCSA DIRECT which covers "[a]rranging and conducting auctions; Auction management services provided to others over an on-line web site accessed through a global computer network; Auction services; On-line auction services," in Class 35 (collectively, the "Marks");

WHEREAS, Assignee is desirous of acquiring the Marks and Assignor is willing to assign the Marks to Assignee pursuant to the terms of this Assignment.

2. Further Assurances. Assignor shall execute and deliver to Assignee such other documents and assignments as may be necessary to consummate or implement this Assignment. Assignee shall be responsible for recording this Assignment with the United States Patent and Trademark Office.
3. Binding Effect. This Assignment shall be binding upon and shall inure to the benefit of the Parties, and their respective successors and assigns.
