ASSIGNMENT

THIS ASSIGNMENT (the "Assignment") is effective as of the date indicated on the signature page (the "Effective Date") by and between Visioneering International, Inc., a Georgia corporation, whose primary corporate office is at 659 Auburn Ave NE, Suite #267, Atlanta, Georgia 30312 ("VII"), and Foah Properties, LLC, a Georgia limited liability company, whose primary corporate office is at 659 Auburn Ave NE, Suite #267, Atlanta, Georgia 30312 ("FP").

WITNESSETH:

WHEREAS, VII owns intellectual property rights in and associated with the VISIONEERING trademark as well as other trademarks, including associated goodwill, used with various goods and services offered by VII, which marks have been used in the United States and have been used internationally (collectively, the "Visioneering Trademark Rights");

WHEREAS, VII currently owns trademark registrations for these trademarks as detailed on Exhibit A (the "Registrations"); and

WHEREAS, VII desires to transfer all its intellectual property rights in and to the Visioneering Trademark Rights, including all associated goodwill and the Registrations, to FP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, VII and FP (each a "Party", and collectively the "Parties") hereby agree as follows:

1. **Assignment.** VII hereby assigns to FP all of VII's right, title and interest in and to the Visioneering Trademark Rights, including all associated goodwill, the Registrations, income and royalties, any money due or that becomes due relating to an infringement or misappropriation of any of them, and the right to sue for all future and past infringements and misappropriations. VII will execute all future documents, papers, forms, and authorizations that may be reasonably requested and necessary to confirm or perfect or otherwise to carry out the intent and purposes of this Assignment. FP will pay VII \$1.00 for such Visioneering Trademark Rights and will make such payment on or about the Effective Date.

2. **Recordation of Trademarks.** If FP elects to record this Assignment with the United States Patent & Trademark Office or applicable state or non-United States governmental or international authorities or registries, FP will bear all costs and fees associated with such recording. VII hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any state or non-United States country whose duty it is to issue trademark registrations to issue all registrations to FP and in FP name.

3. **Past Agreements and VII Representations and Warranties.** VII has entered into various agreements with third parties regarding the Visioneering Trademark Rights ("VII Agreements"). VII hereby transfers all rights, duties and obligations under the VII Agreements to FP. To the extent the VII Agreements are in VII's possession, VII will transfer copies of those

agreements to FP. Other than as detailed in the VII Agreements, VII has not previously transferred or licensed the Visioneering Trademark Rights to any other party, knows of no third party that has rights to the Visioneering Trademark Rights, and represents that such rights are free and clear of all form of liens.

4. **Disclaimer of Warranty.** VII makes no warranty to FP with respect to the Visioneering Trademark Rights, except as expressly stated herein, and any and all other warranties, including any implied fitness for a particular purpose or use, are expressly disclaimed and denied. VII specifically makes no representations or guarantees regarding the ability for FP to use the Visioneering Trademark Rights, that such rights do not infringe any third party rights, that any trademark applications may be filed based on the Visioneering Trademark Rights, or that the Visioneering Trademark Rights will be usable as the basis for obtaining any trademark registration.

5. **Effect of Heirs and Successors.** This Assignment will inure to the benefit of and be binding upon the Parties and their respective successors, executors, administrators, heirs and permitted assigns.

6. **Waiver, Amendment, Modification.** No waiver, amendment or modification, including those by custom, usage of trade, or course of dealing, of any provision of this Assignment will be effective unless in writing. No waiver by either Party of any term or provision of this Assignment, or of any default hereunder, will affect such party's right thereafter to enforce such term or provision or to exercise any right or remedy in the event of any other default, whether or not similar.

7. **Entire Agreement.** This Assignment contains the entire agreement and understanding concerning the subject matter hereof.

8. **Governing Law and Venue.** This Assignment will be governed by and construed in accordance with the laws of the State of Georgia and the United States of America without giving effect to any conflicts of laws rule or principle that might require the application of the laws of another jurisdiction. Any legal proceedings involving this Assignment, or in which this Assignment is raised, will be conducted in the area of the federal Northern District of Georgia and all Parties consent to such venue and to transfer of venue for any suits filed elsewhere to such venue.

9. **Construction of Agreement.** The Parties acknowledge that they were represented (or had the opportunity to be represented) by legal counsel in connection with this Assignment and that each of them and its counsel have reviewed this Assignment, or have had an opportunity to do so, and that any rule of construction to the effect that ambiguities are to be resolved against the drafting party will not be employed in the interpretation of this Assignment or any amendments or any exhibits thereto.

IN WITNESS WHEREOF, the Parties have executed this Assignment to be effective as of the Effective Date.
