I, James Korth, having an address at 11 ROSEMARY DR., SINKING SPRING, PA do hereby swear and affirm as follows:

1. I am the President of 997494 Ontario Limited, the General Partner of Jade Swimwear, LP, a Pennsylvania limited partnership, located in Mohnton, Pennsylvania.

2. Jade Swimwear, LP is the successor-in-interest to the following trademarks and registrations (hereinafter the Trademarks):

3. In 1987, the Trademarks were owned by Dolfin International Corporation, a Pennsylvania corporation. I was the President of Dolfin International Corporation in 1987 and am currently the President of Dolfin International Corporation.

4. In 1987, Dolfin International Corporation obtained a line of credit from Meridian Bank, a Pennsylvania banking corporation, secured by an interest in the Trademarks.

5. The line of credit from Meridian Bank to Dolfin International Corporation was subsequently paid off, and there is no remaining outstanding debt owed to Meridian Bank or any of its successor banks by Dolfin International Corporation or any of the successors-in-interest to the Trademarks.
