RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest ("Release") is made effective as of April 29, 2016 by JPMorgan Chase Bank, N.A., (the "Lender") for itself and as Administrative Agent for the Lenders to Ophir-Spiricon, LLC, a Utah limited liability company (the "Debtor"), as follows:

WHEREAS, on July 18, 2013, Debtor and the Lender entered into a Pledge and Security Agreement ("Security Agreement") and a Confirmatory Grant of Security Interest in Trademarks ("Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, Debtor granted to Lender, among other collateral, a continuing security interest in all of the Debtor's right, title and interest, including goodwill, in, to and under its United States trademarks listed on the attached Exhibit A (the "Trademarks");

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on July 22, 2013, at reel/frame 05075/0646; and

WHEREAS, the Lender wishes to release its security interest in the Trademarks and retransfer and reassign to Debtor without recourse all of the Lender's right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby states as follows:

1. Release of Security Interest. The Lender terminates, releases and discharges its security interest in and to the Trademarks, and reassigns to the Debtor any and all right, title and interest it may have in and to the Trademarks, without recourse to Debtor.

2. Further Assurances. The Lender agrees to execute, acknowledge, procure and deliver to Debtor any and all further documents or instruments and do any and all further acts which the Debtor (or their respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Debtor's (or their assignees') right, title and interest in and to the Trademarks.
