Assignor further confirms that it has assigned to Assignee all right, title, and interest in and to all claims for damages by reason of past or current infringement or misuse of the Trademarks, together with the right to sue for, collect, and retain the proceeds relating to any such infringement or misuse.

Assignor covenants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into by Assignor which would conflict with this Assignment.




