CORRECTIVE CONFIRMATORY ASSIGNMENT OF TRADEMARK

THIS CORRECTIVE CONFIRMATORY ASSIGNMENT OF TRADEMARK (this "Assignment") is made effective as of February 7, 2012, by and between Ohio Energy Holdings Corp., an Ohio corporation, having its place of business at 40 West First Avenue, Columbus, Ohio 43201 ("OEHC"), and ImproveIt! 360, LLC, an Ohio limited liability company, having its place of business at 130 East Chestnut Street, Suite 200, Columbus, Ohio 43215 (the "Company").

WHEREAS, as of the effective date of this Assignment, OEHC was the owner of all right, title and interest in and to certain marks, including but not limited to the mark IMPROVE IT, which is the subject of U.S. Registration No. 3,013,714 (the "Mark");

WHEREAS, the parties hereto intended for all of OEHC's right, title and interest in certain marks other than the Mark to be transferred to the Company effective as of February 7, 2012, and did so transfer such rights;

WHEREAS, on or about June 18, 2015, the parties hereto executed a Confirmatory Assignment of Trademark that confirmed the transfer of rights intended to be effective as of February 7, 2012 actually took place as of that date (the "Confirmatory Assignment");

WHEREAS, the Confirmatory Assignment was subsequently recorded at Reel 5563, Frame 0510;

WHEREAS, subsequent to the recordation of the Confirmatory Assignment, the parties discovered that the Mark had inadvertently been included among the rights subject to the Confirmatory Assignment despite it not being intended to be transferred to the Company effective as of February 7, 2012;


WHEREAS, OEHC has always been the beneficial owner of the Mark; and,


WHEREAS, the parties desire to correct the record of the chain of title of the Mark to account for the inadvertent inclusion of the Mark as part of the transfer of rights effective as of February 7, 2012.

NOW, THEREFORE, the Company hereby confirms that, effective as of February 7, 2012, it sold, assigned, and transferred back to OEHC all right, title and interest in and to (i) the Mark, (ii) all income, royalties, damages and payments now or hereafter due or payable with respect to the Mark, (iii) all rights of action arising from the Mark, including all claims for damages by reason of past, present and future infringement of the Mark and the right to sue and collect damages for such infringement, to be held and enjoyed by OEHC for its own use and

benefit and for its successors and assigns as the same would have been held by the Company had the inadvertent assignment of the Mark not been made, and (iv) the goodwill of the business symbolized by the Mark.

IN WITNESS WHEREOF, the parties have executed this Assignment as of the date set forth above.
