**TERMINATION OF TRADEMARK SECURITY AGREEMENT AND
RELEASE OF SECURITY INTEREST**

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST** (this "*Termination and Release*") is granted as of April 15, 2016 by **WINTRUST BANK**, an Illinois banking corporation formerly known as North Shore Community Bank & Trust Company (the "*Assignee*"), in favor of **ONION, INC.**, a Wisconsin corporation ("*Grantor*"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Agreement (as hereinafter defined).

WHEREAS, Grantor executed and delivered a Trademark Security Agreement dated as of April 25, 2013 (as amended, modified or supplemented prior to the date hereof, the "*Trademark Agreement*"), granting to the Assignee a security interest in and lien on certain Trademark Collateral described therein;

WHEREAS, the Trademark Agreement was recorded in the Assignments Recordation Branch of the United States Patent and Trademark Office ("*USPTO*") on May 14, 2013, at Reel 005027, Frame 0376;

WHEREAS, Grantor has requested that the Assignee hereby terminate, release and discharge fully its security interest in and lien on the Trademark Collateral and all right, title and interest of the Grantor in, to and under all of the Trademark Collateral described in the Trademark Agreement, as herein provided; and

WHEREAS, Grantor has requested that the Assignee provide a document suitable for recording in the USPTO to evidence the release of its security interest in and lien on the Trademark Collateral, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Trademark Agreement and releases, terminates and discharges fully all liens and security interests in and to (a) the Trademark Collateral and (b) Grantor's right, title and interest in, to and/or under the Trademark Collateral; including without limitation those trademarks, trademark applications and trademark registrations identified in Schedule 1 hereto and the goodwill associated therewith, the debts secured by said Trademark Agreement having been paid and satisfied in full;
2. authorizes and requests that this Termination and Release be recorded in the USPTO; and,
3. agrees that it shall, and at Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable, for the release of such liens and security interests.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF ILLINOIS.


