## SHORT-FORM TRADEMARK SECURITY AGREEMENT

WHEREAS, each signatory (each an “Obligor”) to this Short-Form Trademark Security Agreement (“Agreement”), dated as of April 22, 2016, is the owner of the trademarks and the registrations and pending applications associated therewith listed under its respective name on Schedule I attached hereto; and

WHEREAS, pursuant to (1) that certain Sixth Amended and Restated Credit Agreement dated as of July 31, 2014, as amended by the First Amendment to the Sixth Amended and Restated Credit Agreement and First Amendment to the Fourth Amended and Restated Security Agreement, dated as of April 30, 2015, and as further amended by Incremental Loan Amendment No. 1, dated as of April 30, 2015 (as further amended, amended and restated, supplemented and otherwise modified and in effect from time to time, the “Credit Agreement”) and (2) that certain Fourth Amended and Restated Security Agreement dated as of April 9, 2013, as amended by the First Amendment to the Sixth Amended and Restated Credit Agreement and First Amendment to the Fourth Amended and Restated Security Agreement, dated as of April 30, 2015 (as further amended, amended and restated, supplemented and otherwise modified and in effect from time to time, the “Security Agreement”), each Obligor jointly and severally agrees with JPMorgan Chase Bank, N.A., as administrative agent for the Lenders party to the Credit Agreement referred to therein (in such capacity, together with its successors in such capacity, the “Administrative Agent”) to execute this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Obligor hereby grants to the Administrative Agent for the benefit of the Secured Parties (as such term is defined in the Credit Agreement), according to the terms of the Security Agreement, a security interest in all of its right, title and interest in, to and under all the Trademark Collateral (as such term is defined in the Security Agreement) of such Obligor located in the United States of America, together with, among other things, the good-will of the business symbolized by the Trademark Collateral, including its respective trademarks listed on Schedule I attached hereto, and all registrations and pending applications associated therewith, as collateral security for the payment in full when due (whether at stated maturity, by acceleration or otherwise) of the Obligations (as such term is defined in the Credit Agreement).
