 - c. To the extent possible, each provision of this Assignment shall be interpreted in a manner as to be valid, legal and enforceable. Any determination that any provision of the within Assignment or any application thereof is invalid, illegal or unenforceable in any respect in any instance shall not affect the validity, legality and enforceability of such provision in any other instance, or the validity, legality or enforceability of any other provision of the within Assignment.

- d. Each party hereto intends that this Assignment shall not benefit or create any right or cause of action in or on behalf of any person other than the parties hereto.
