Assignor hereby confirms the assignment to Assignee effective as of January 29, 2016, and otherwise assigns, all right, title and interest, in and to (i) the trademarks set forth in Exhibit A hereto; (ii) the domain names assigned in the Bill of Sale and Assignment Agreement; (iii) any trademarks, service marks, domain name or other source identifier that is a derivative of or confusingly similar to any of the trademarks set forth in Exhibit A, and (iv) the good will and common law rights associated with any of the foregoing ("the Assigned Marks"), as well as the right to file for protection of the Assigned Marks in any jurisdiction and the right to sue for infringement of the Assigned Marks. At Assignee's request, Assignor agrees to perform all acts and execute all documents necessary for Assignee to perfect its ownership in and to the Assigned Marks.

This Assignment may be executed in multiple counterparts, each of which will be deemed an original and all of which when taken together, will constitute one and the same instrument.

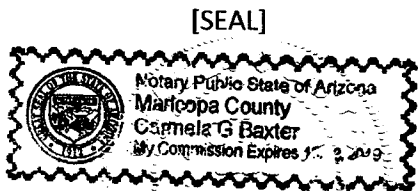

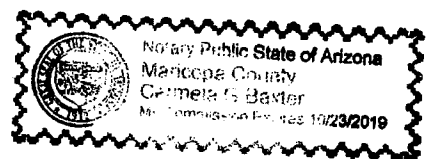
