OF  
AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of RCW 23B.10.060, the undersigned corporation adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

**FIRST:** The name of the corporation is McKinstry Essention, Inc. (the "Corporation").

The name of this corporation is McKEss Holdings, Inc.

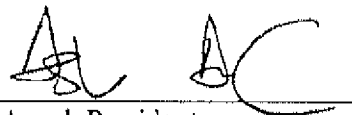
**THIRD:** This amendment does not provide for an exchange, reclassification or cancellation of issued shares.
