## TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, **Assignor** has sold, assigned and transferred and by these presents does irrevocably and in perpetuity sell, assign and transfer unto the **Assignee**, its successors and assigns, the full and exclusive right, title and interest in and to the Trademark, together with (a) the current registrations and any renewals or extensions thereto; (b) the goodwill of the business symbolized by and associated with the Trademark and the registration thereof; and (c) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Trademark or the registrations thereof or such associated goodwill.

**Assignor** hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale;

**Assignor** hereby authorizes and requests the Patent and Trademark Officials in the United States of America and any and all foreign countries to issue any registrations when granted to **Assignee**, as the assignee of **Assignor's** entire right, title and interest in and to the same for the sole use and behalf of **Assignee**, its successors and assigns, to the full end of the term for which any of said registrations may

be granted as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made;

Further, Assignor agrees to communicate to Assignee, or its representatives any facts known to Assignor respecting said Trademark to testify in any legal proceeding, to sign all lawful papers, to make all rightful oaths and generally to do everything possible to aid the Assignee, its successors and assigns to obtain and enforce proper protection for said marks and works listed in the United States of America and in any and all foreign countries without further compensation, but at the expense of Assignee, its successors, assigns or other legal representatives; and

Assignor hereby appoints the President or any other officer of Assignor as Assignor's attorney-in-fact and agent to execute all documents required or appropriate to perfect or enforce all rights assigned under this Assignment and further authorizes Assignor's attorney and attorneys and the attorney and attorneys for Assignee to register this assignment in any and all countries.

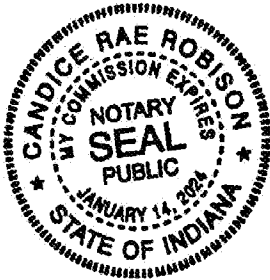
