TERMINATION OF SECURITY AGREEMENT

WHEREAS, MEDINATURA, INC., a Delaware corporation, and MEDINATURA NEW MEXICO, INC. f/k/a HEEL, INC., a New Mexico corporation, (collectively the "Company") executed and delivered in favor of M&T BANK, a New York banking corporation (the "Bank"), that certain Security Agreement dated as of August 29, 2014 (the "Security Agreement"); and

WHEREAS, the Company is the owner of the copyright registrations, trademark or service mark registrations, patents and licenses (collectively the "Intellectual Property") listed on Schedule A attached hereto; and

WHEREAS, pursuant to the Security Agreement recorded with the United States Patent and Trademark Office on September 4, 2014 at Reel 5356 and Frame 0437, the Company granted to the Bank, inter alia, a perfected first priority security interest in and to the Intellectual Property; and

WHEREAS, the parties now desire to terminate the Bank's security interest in the Intellectual Property.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, the Bank hereby agrees as follows:

1. Effective as of the date hereof, the Security Agreement is hereby terminated, and of no further force or effect.
2. The Bank hereby acknowledges that all indebtedness and obligations of the Company to the Bank have been paid and are satisfied.
3. The Bank hereby releases its security interest and conveys back to the Company all of the Bank's interest in and to the Intellectual Property.
4. The Bank agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Intellectual Property.

IN WITNESS WHEREOF, the undersigned has executed this Termination of Security Agreement as of this 5th day of May, 2016.
