

TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 15, 2015, by Wells Fargo Bank, National Association (in such capacity, "<u>Agent</u>"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Hickory Springs Manufacturing Company, a North Carolina corporation ("HSMC"), PTI, Inc., a North Carolina corporation, Spiller Spring Company, a Wisconsin corporation, Hickory Springs of California, LLC, a North Carolina limited liability company, The C.E. White Co., an Ohio corporation, Hickory Springs Global Components Holdings, LLC, a Delaware limited liability company, and Plastic Technology, Inc., a North Carolina corporation (collectively, the "Grantors") and Agent were parties to that certain Trademark Security Agreement dated as of September 25, 2015 (the "Security Agreement"), pursuant to which the Grantors granted a security interest to Agent in certain trademarks ("Trademarks") and Trademark Collateral (as defined below) as security for certain obligations owing by the Grantors to Agent, including the Trademarks set forth on Schedule 1 hereto;

 - (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party referred to on Schedule 1;
 - (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License referred to on Schedule 1; and
 - (c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by HSMC against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.
- 2. Agent hereby reassigns, grants and conveys to HSMC, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademarks and the Trademark Collateral referred to on Schedule 1.

3. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
