ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF
HUBBARD FEEDS INC.

- 1. The name of the corporation is Hubbard Feeds Inc.
- 2. The following is the full text of the amendment to the Amended Articles of Incorporation of Hubbard Feeds Inc.:

RESOLVED, that Article 1 of the Corporation's Amended Articles of Incorporation is hereby amended in its entirety to read as follows:

ARTICLE 1. NAME

The name of the corporation is "Ridley USA Inc."

FURTHER RESOLVED, that the foregoing change will be effective upon the date of filing with the Office of the Minnesota Secretary of State of a proper Certificate evidencing such change, and the officers of the Corporation are directed to execute and file such Certificate.
