INTELLECTUAL PROPERTY RELEASE

THIS INTELLECTUAL PROPERTY RELEASE is made as of May 3, 2016, by SILICON VALLEY BANK ("Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, ACCESSDATA GROUP, INC. (the "Grantor") and Secured Party are parties to that certain Amended and Restated Intellectual Property Security Agreement dated as of June 30, 2015 (the "IP Security Agreement") pursuant to which Grantor granted a security interest to Secured Party in certain Intellectual Property Collateral (as that term is defined in the IP Security Agreement) as security for certain obligations owing by Grantor to Secured Party pursuant to that certain **Amended and Restated Loan and Security Agreement** by and between Secured Party and Grantor dated the Effective Date (as the same may be amended, modified or supplemented from time to time) (the "Security Agreement");

WHEREAS, prior to entering into the aforementioned IP Security Agreement and Security Agreement, Grantor (under its former name, ACCESSDATA GROUP, LLC) and Secured Party were parties to that certain Intellectual Property Security Agreement (the "Prior IP Security Agreement") pursuant to which Grantor granted a security interest to Secured Party in certain Intellectual Property Collateral (as that term is defined in the Prior IP Security Agreement) as security for certain obligations owing by Grantor to Secured Party pursuant to that certain **Loan and Security Agreement** by and between Secured Party and Grantor (under its former name, ACCESSDATA GROUP, LLC) dated the Effective Date (as the same may be amended, modified or supplemented from time to time) (the "Prior Security Agreement"), and together with the IP Security Agreement, Security Agreement, and the Prior IP Security Agreement, collectively, the "Security Documents";

WHEREAS, the Prior IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame Nos. 4988/0473 and 5458/0570 with respect to Trademarks and at Reel/Frame No. 034963/0385 with respect to Patents; and

WHEREAS, Grantor has fulfilled its obligations under the Security Documents and requests Secured Party to terminate, release, and discharge its security interest in the Intellectual Property Collateral (for purposes of clarity, including all Intellectual Property Collateral as defined in the IP Security Agreement and all Intellectual Property Collateral as defined in the Prior IP Security Agreement), including, without limitation, those items set forth on Exhibit A, attached hereto (all of the foregoing, collectively, the "IP Collateral") and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby absolutely, unconditionally and irrevocably terminates, releases, and discharges its lien on and security interest in all of Grantor's right, title and interest in and to the IP Collateral.
2. Secured Party hereby absolutely, unconditionally and irrevocably reassigns, grants, and conveys to the Grantor, without warranty or representation of any kind, any and all of Secured Party's right, title and interest (if any) in and to the IP Collateral.

3. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America or her delegate, and the Register of Copyright for the United States Copyright Office or her delegate, to record this Intellectual Property Release against the IP Collateral. The Secured Party hereby represents and warrants that it has full authority to execute and deliver this Intellectual Property Release.

4. Secured Party hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be requested by the Grantor to affect the release of its security interest contemplated hereby.
