RELEASE OF SECURITY INTEREST
IN TRADEMARKS

AXIALL OHIO, INC., ROME DELAWARE CORP., AXIALL, LLC, ROYAL GROUP, INC. / GROUPE ROYAL, INC. (each, a "Grantor") and collectively, the "Grantors") executed and delivered a Trademark Security Agreement dated December 17, 2014 (the "Agreement") in favor of GENERAL ELECTRICAL COMPANY (AS SUCCESSOR BY INTEREST OF MERGER TO GENERAL ELECTRIC CAPITAL CORPORATION), as administrative agent (the "Agent") for the Secured Parties (as defined in the Agreement) pursuant to which each Grantor granted to the Agent a security interest in and to all of such Grantor's right, title and interest in and to all of its trademarks and trademark applications and all proceeds thereof, including the specific trademarks listed on Exhibit A attached hereto (the "Released Marks"), and the goodwill associated therewith. The Agreement was recorded in the United States Patent and Trademark Office ("USPTO") at Trademark Reel/Frame Number 5422/0673 - 0681 (recorded on December 19, 2014).

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent, on behalf of itself, its successors, legal representatives and assigns and each of the Secured Parties, hereby (i) terminates, releases, and discharges fully its security interest in and to the Released Marks, and the goodwill associated therewith, (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Marks, and the goodwill associated therewith, and (iii) reassigns, grants, and conveys to the Grantors any and all right, title and interest it has in the Released Marks, and the goodwill associated therewith.

The Agent agrees, at the expense of the Grantors, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the Released Marks.

The Grantors, or their designee, may record this Release of Security Interests in Trademarks in the USPTO and in any other offices as may be necessary to carry out the intention of this Release of Security Interests in Trademarks, and to the extent applicable, the parties hereto authorize and request that the USPTO record this Release of Security Interest in Trademarks.

This Release of Security Interest in Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York.


