## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("**Trademark Assignment**"), dated as of 04 April 2015, is made by First National Innovation Brokers, Ltd., ("**Assignor**"), a New Zealand Company, located at Plaza Level, 41 Shortland Street, Auckland 1010 New Zealand, in favor of Daniel Bruno ("**Buyer**"), an Individual, located at 1259 El Camino Real, Menlo Park, California 94025 between Assignor and Assignee, dated as of 01 April 2015 (the "**Principal Agreement**").

1. **Assignment.** In consideration of \$15 million for SWIFTCOIN and \$75,000 for FXBOSS paid by Assignee upon execution of this Trademark Assignment, Assignor hereby irrevocably conveys, transfers and assigns to Assignee all of Assignor's right, title and interest in and to the following (the "**Assigned Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks:

(a) the trademarks, trademark registrations and trademark applications set forth below, as well as on Schedule 1 hereto and all issuances, extensions and renewals thereof; provided that, only with respect to United States intent-to-use trademark applications, the transfer of such applications shall not be effective until the expiration of any period during which the assignment thereof would impair, under applicable federal law, the registrability of such applications or the validity or enforceability of registrations issuing from such applications;




