## TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE, its successors and assigns, all of ASSIGNOR's right, title, and interest of whatever kind in and to the Marks and the Property, including, without limitation, (1) the goodwill of the business relating to the goods and services in respect upon which the Marks are used and for which the Marks shall be registered, the ASSIGNOR Applications, and all rights to sue for past, present and future infringements and misappropriations of the Mark and/or the Property.

ASSIGNOR represents and warrants that ASSIGNOR is the exclusive owner of the Marks and the Property, that ASSIGNOR has used the Marks in commerce in connection with its business, that such business is ongoing and existing, that ASSIGNOR possesses all right, title and interest in and to the Marks and the Property, that ASSIGNOR has the power to enter into this assignment; and that the rights transferred in this assignment are free of any liens, encumbrances or adverse claims. ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary to secure, complete or vest in ASSIGNEE full right, title, and interest in the Marks and the Property.
