## CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Assignment is made by and between Coveroo, Inc., a Delaware corporation located at 333 Bryant Street, LL120, San Francisco, California 94107 ("Assignor"), and Fanmade Inc., a Delaware located at 1800 Seaport Boulevard, Redwood City, California 94063 ("Assignee").

### RECITALS

WHEREAS, Assignor and Assignee execute this Confirmatory Trademark Assignment for the sole purpose of confirming, memorializing, and recording the Assignment effected pursuant to the Agreement.

NOW THEREFORE, in exchange for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties agree as follows:

### ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby transfers, sells, assigns, conveys and delivers to Assignee and its successors and assigns, Assignor's entire right, title and interest in and to the Trademark, together with the goodwill associated therewith.



This includes, but is not limited to, any rights with respect to the Trademark that may have accrued in Assignor's favor from the respective

date of first use of the Trademark from the Effective Date of this Assignment. Assignor hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.
