**DOES HEREBY CERTIFY:**

**FIRST:** That the name of this corporation is TechMediaNetwork, Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on June 12, 2008 under the name TopTenREVIEWS, Inc.

**SECOND:** That the Board of Directors of this corporation duly adopted resolutions setting forth a proposed amendment to the Amended and Restated Certificate of Incorporation of this corporation, as amended (the "Restated Certificate"), declaring said amendment to be advisable and in the best interests of this corporation and its stockholders and authorizing the appropriate officers of this corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment is substantially as follows:

**RESOLVED**, that Article I of the Restated Certificate be deleted and replaced in full with the following:

**"ARTICLE I**

The name of the Corporation is Purch Group, Inc. (the "**Corporation**").

**THIRD:** That thereafter said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by written consent of the stockholders holding the requisite number of shares required by statute given in accordance with and pursuant to Section 228 of the General Corporation Law.
