

This Certificate of Conversion to Limited Partnership, dated as of July 24, 2015 (the "**Certificate**"), is being duly executed and filed by the undersigned to convert Stancor, LLC, a Delaware limited liability company (the "**LLC**"), to Stancor, L.P., a Delaware limited partnership (the "**LP**") under the Delaware Revised Uniform Limited Partnership Act, 6 Del. C. §§ 17-101, et seq. (the "**Act**").

1. The LLC was originally formed as a Delaware limited liability company under the name "Stancor, LLC" by the filing of its Certificate of Formation with the Secretary of State of the State of Delaware on July 23, 2015, and the jurisdiction of the LLC immediately prior to its conversion was the State of Delaware.


2. The LLC's name immediately prior to filing this Certificate was "Stancor, LLC".

3. The name of the Delaware limited partnership into which the LLC shall be converted as set forth in its certificate of limited partnership as filed in accordance with Section 17-217(b) of the Act is "Stancor, L.P."

4. The conversion of the LLC to the LP shall be effective upon the filing of this Certificate and the certificate of limited partnership with the Secretary of State of the State of Delaware.
