## ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks may not be assigned by any party hereto without the prior written consent of the other party hereto, and any purported assignment without such consent shall be void; provided, however, that OTS may assign its rights hereunder to any affiliate of OTS (in which case OTS nonetheless shall remain responsible for the performance of all of its obligations hereunder).
