**CONFIRMATORY GRANT OF SECURITY INTEREST
IN TRADEMARKS**

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS AND RELATED APPLICATIONS, (this "Grant of Security Interest") is made effective as of the 10th day of MAY, 2016 (the "Effective Date"), by and from Arcadia Publishing, Inc., a South Carolina corporation ("Grantor"), to and for NBSC, a Division of Synovus Bank ("Grantee").

WHEREAS, Grantor is the owner of those certain federal registrations for trademarks listed on Schedule A, attached hereto and incorporated herein by reference (collectively, the "Trademarks"); and

WHEREAS, Grantor desires to confirm and perfect the security interest in the Trademarks (the "Security Interest") in accordance with the Security Agreement dated as of July 3, 2014 by and between Grantor and Grantee (the "Security Agreement");

NOW, THEREFORE, in consideration of the mutual covenants, warranties and promises set forth in the Security Agreement, and other good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants and conveys unto Grantee a first lien Security Interest in and to: (i) all trademarks now owned or hereafter acquired by the Grantor, including, without limitation, the Trademarks (collectively, the "Intellectual Property"); (ii) any federal or state applications filed with respect to the Intellectual Property; (iii) any federal or state registrations issued or issuing with respect to the Intellectual Property; (iv) all proceeds of the Intellectual Property, including, but not limited to, any and all royalties and any claims and demands arising out of any infringement of the Intellectual Property, including the right to settle disputes concerning such claims and demands; and (v) all goodwill associated with the Intellectual Property, such grant being hereby effected for the purposes and subject to the terms and conditions set forth in the Security Agreement.

Grantor hereby appoints Grantee, with full power of substitution, to file and record this Grant of Security Interest, to transact all business in the United States Patent and Trademark Office in connection therewith, to receive any confirmatory documents relating thereto, and to take any and all action before the Patent and Trademark Office to give effect to this Grant of Security Interest.


