Pursuant to the provisions of Section 209(c) of the Delaware Limited Liability Company Act, as amended, the undersigned merging Delaware limited liability company and surviving foreign Alabama corporation hereby submit the following certificate of merger:

1. Surviving Party. The party surviving the merger will be Progress Rail Services Corporation, a foreign corporation formed in the State of Alabama ("Progress Rail").

2. Merging Party. The limited liability company being merged into the foreign corporation is Rail Product Solutions LLC, a Delaware limited liability company and a wholly owned subsidiary of Progress Rail ("RPS")

3. Plan of Merger. An Agreement and Plan of Merger dated as of January 15, 2016 (the "Plan"), pursuant to which RPS will merge with and into Progress Rail, has been approved and executed by each of RPS and Progress Rail, all in accordance with applicable Alabama and Delaware law. Pursuant to the Plan, all membership interests in RPS will automatically, by virtue of the merger and without any action on the part of the holder thereof, be cancelled.

4. Copy of Plan. A copy of the Plan is on file with Progress Rail at its principal place of business located at 1600 Progress Drive, P.O. Box 1037, Albertville, AL 35950. Upon request, a copy of the Plan will be furnished without cost by Progress Rail to any person holding an interest in either party to the merger.

5. Service of Process in Delaware. Progress Rail agrees, pursuant to Section 209(c)(8) of the Delaware Limited Liability Company Act, that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of RPS. Progress Rail irrevocably appoints the Delaware Secretary of State as its agent to accept service of process in any such action, suit or proceeding. The address to which a copy of such process shall be mailed to it by the Delaware Secretary of State is 1600 Progress Drive, P.O. Box 1037, Albertville, AL 35950.
