**PARTIAL TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY
AGREEMENT WITH RESPECT TO CERTAIN PATENTS AND TRADEMARKS**

THIS PARTIAL TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT WITH RESPECT TO CERTAIN PATENTS AND TRADEMARKS (this “Release”), is dated as of May 15, 2013, and made by **JPMORGAN CHASE BANK, N.A.**, as administrative agent and collateral agent (in such capacities, the “Agent”) to **INTERNATIONAL TRUCK INTELLECTUAL PROPERTY COMPANY, LLC**, an Illinois limited liability company (“Grantor”); unless defined herein, capitalized terms used herein shall have the meanings assigned to such terms in the Credit Agreement (as defined in the Patent and Trademark Security Agreement referred to below).

WHEREAS, Navistar RV, LLC, a Delaware limited liability company (“Navistar RV”), Navistar, Inc., a Delaware Corporation (“Navistar”), Workhorse International Holding Company, a Delaware corporation (“Seller”), Allied Specialty Vehicles, Inc., a Delaware corporation (“ASV”), ASV/MRV, Inc., a Delaware corporation (“MRV”), Motorized Co. LLC, a Delaware limited liability company (“Motorized Buyer”), Towables Co. LLC, a Delaware limited liability company (“Towables Buyer,” and together with ASV, MRV and Motorized Buyer, each a “Buyer Party” and collectively the “Buyer Parties”) have entered into that certain Securities and Asset Purchase and Contribution Agreement, dated as of May 15, 2013 (the “Purchase Agreement”), pursuant to which the Seller will dispose of the Capital Stock of Navistar RV together with certain other property to the Buyer Parties (the “Sale”);

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement, dated as of August 17, 2012, (as amended, restated, supplemented or otherwise modified from time to time, including all schedules thereto, the “Security Agreement”), Grantor, along with Navistar, Navistar RV and other certain affiliated entities, granted to Agent a security interest in certain collateral, including the Patent Collateral and Trademark Collateral (as each is hereinafter defined);

WHEREAS, the Security Agreement was recorded (a) in the Patent Division of the United States Patent and Trademark Office on September 12, 2012, at Reel 28944 and Frame 0730, and (b) in the Trademark Division of the United States Patent and Trademark Office on September 12, 2012, at Reel 4859 and Frame 0294;

WHEREAS, in connection with the Sale, (a) Grantor has assigned to Navistar RV the Patent Collateral and Trademark Collateral, and (b) Agent has agreed to release its lien and security interest in the property and assets of Navistar RV, which include the Patent Collateral and Trademark Collateral; and

WHEREAS, Agent now desires to terminate and release the Security Agreement with respect to the Patent Collateral and Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Agent hereby agrees as follows:

1. Definitions.

1.1 The term “Trademark Collateral,” as used herein, shall mean all right, title and interest in, to and under any and all of the following assets:

(a) all U.S. trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States of America, and all

extensions or renewals thereof, that are, in each case, owned by Navistar RV, including those listed on Schedule A hereto; and

(b) all goodwill associated therewith or symbolized thereby.

1.2 The term "Patent Collateral," as used herein, shall mean all right, title and interest in, to and under any and all of the following assets:

(a) all letters patent of the United States of America, all registrations and recordings thereof, and all applications for letters patent of the United States of America, including registrations, recordings and pending applications in the United States Patent and Trademark Office, that are, in each case, owned by Navistar RV, including those listed on Schedule A hereto; and

(b) all reissues, continuations, divisions, continuations-in-part, renewals or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein

2. Release of Security Interest. Agent hereby terminates, releases and discharges its security interest in the Patent Collateral and Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in and to the Patent Collateral and Trademark Collateral. Agent hereby authorizes Grantor or its designee to file this Release with the USPTO.

3. Miscellaneous.


(a) The execution and delivery of this Release shall be without recourse to or warranty by the Agent.

(b) Nothing in this Release shall be construed to act as a release of, or prejudice the rights of the Agent or the Secured Parties in, the security interest created under any Collateral Document in any Collateral, other than the Patent Collateral and Trademark Collateral.
