Assignor represents and warrants to Assignee that it is the owner of the Trademark and the associated goodwill and no third party has any right, title or interest in connection therewith. Assignor shall indemnify and hold Assignee harmless from any damage or liability arising from any third party claim that it has an interest in the Trademark or related good will.
