**CONFIRMATORY RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF
COLLATERAL AGREEMENT**

This Confirmatory Release of Security Interest and Reassignment of Collateral Agreement ("Confirmatory Agreement") is dated as of May 2nd, 2016 by and between EDM Consulting, LLC, a Delaware limited liability company (hereinafter "EDM") and successor-in-interest to Enviroplan, Inc., a New Jersey corporation (hereinafter "Enviroplan"), on the one hand, and Silicon Valley Bank, a California corporation (hereinafter "SVB"), on the other hand. EDM and SVB hereby agree as follows:

WHEREAS, pursuant to an Assignment of Patents and Trademarks dated June 4, 1992 (the "Collateral Assignment") between SVB and Enviroplan, Enviroplan assigned to SVB its interest in all Collateral (as defined in the Collateral Assignment), as collateral security for all the Secured Obligations (as defined in the Collateral Assignment) to SVB; and

WHEREAS, the Collateral Assignment was recorded in the U.S. Patent and Trademark Office on June 22, 1992 at Reel/Frame: 0876/0889; and

WHEREAS, all of the Secured Obligations have been satisfied.

NOW, THEREFORE, in consideration for good and valuable consideration, receipt of which is hereby acknowledged:

1) SVB hereby agrees that as of the date the Secured Obligations were satisfied all assignments and security interests created by the Collateral Assignment and any proceeds thereof or distributions in respect thereof were released and that all of SVB's right, title, and interest in the Collateral was reassigned to Enviroplan or its successors or assigns without representation or warranty;

2) SVB hereby assigns to EDM without representation or warranty all right, title, and interest that SVB may have in the Collateral, including but not limited to the trademarks set forth on Schedule A hereto together with the goodwill of the business symbolized thereby;

3) SVB hereby agrees and confirms that any security interests created by the Collateral Assignment and any proceeds thereof or distributions in respect thereof have been terminated and released;

4) SVB hereby agrees and confirms that all obligations or commitments or warranties owed or provided to SVB pursuant to the Collateral Assignment have been terminated and released;

5) SVB hereby agrees to execute and deliver all further deeds, assignments and other instruments as may be reasonably requested by EDM or any person or entity on behalf of EDM to otherwise confirm, effectuate, record, or evidence the terms of this Confirmatory Agreement, provided, that any costs or expenses incurred by SVB with respect to such items (including all

reasonable attorneys' fees and expenses, if any) shall be reimbursed promptly by EDM on demand;

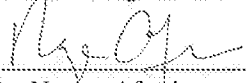
6) SVB hereby agrees that any power of attorney or similar rights granted to SVB pursuant to or in connection with the Collateral Assignment is terminated; and

7) SVB hereby authorizes and requests that the Patent and Trademark Office note and record the existence of the terms of this Confirmatory Agreement and the filing of Uniform Commercial Code termination statements and any other filings necessary to evidence the terms of this Confirmatory Agreement.

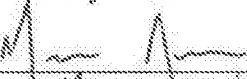
The validity, interpretation and enforcement of this Confirmatory Agreement shall be governed by and construed in accordance with the laws of the State of Massachusetts, without regard to its conflicts of law doctrine. This Confirmatory Agreement shall be binding upon EDM and SVB and their respective successors and assigns.
