INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** ("**Agreement**") is entered into this 15th day of April, 2015 (the "**Effective Date**") by and between **CORAID, INC.**, a Delaware corporation ("**Assignor**") and **INTERMODAL DATA, INC.**, a Delaware corporation ("**Assignee**").

RECITALS

WHEREAS, Assignor and Assignee are party to that certain Foreclosure Agreement, dated as of March 24, 2015, by and among TriplePoint Venture Growth BDC Corp. ("**Lender**"), Assignor and Assignee (the "**Foreclosure Agreement**"), pursuant to which Assignee agreed to purchase from Lender the Collateral, (as such term is defined in the Foreclosure Agreement), including all Intellectual Property (as such term is defined in the Foreclosure Agreement) (the "**Assigned IP**") which purchase was made pursuant to that certain Secured Party Bill of Sale, dated as of April 15, 2015, by and between Lender and Assignee (the "**Bill of Sale**", and together with the Foreclosure Agreement, the "**Sale Agreements**").

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. As of the Effective Date, Assignor irrevocably conveys, assigns, and transfers to Assignee, its successors and assigns, and Assignee hereby accepts, all of their right, title and interest, throughout the world in perpetuity, including common law rights, in and to the Assigned IP, including, without limitation, the Assigned IP listed on **EXHIBIT A**, free and clear of any encumbrances, together with the goodwill associated therewith, and the right to sue and recover for all past, present and future infringements and other violations of the Assigned IP, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had this assignment not been made.
2. Assignor hereby covenants and agrees to provide any further necessary documentation and perform further acts reasonably requested by Assignee necessary to confirm and perfect title in and to the Assigned IP in Assignee, each at Assignee's cost and expense.
3. The parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office, the United States Copyright Office, applicable domain name registrars and/or the applicable foreign authorities to record Assignee as the assignee and owner of the Assigned IP.
4. This Agreement is in all respects subject to the Sale Agreements, which shall govern the respective rights of Lender, Assignor and Assignee, with respect to the Assigned IP, and nothing contained in this Agreement shall in any way supersede, modify, replace, amend, change, rescind, waive, defeat, limit, impair, expand, exceed, enlarge or affect the provisions set forth in, or any Person's rights, remedies or obligations under, the Bill of Sale. This Agreement is intended solely to affect the transfer of the Assigned IP pursuant to the Sale Agreements. To the extent that any provision of this Agreement is inconsistent or conflicts with the Sale Agreements, the Sale Agreements shall control. Each of

Assignor and Assignee, by its execution of this Agreement, hereby acknowledges and agrees that neither the representations and warranties nor the rights, remedies or obligations of any party under the Purchase Agreement shall be deemed to be enlarged, modified or altered in any way by this Agreement.

5. This Agreement shall be construed in accordance with, and governed in all respects by, the internal laws of the State of California (without giving effect to principles of conflict of laws to the extent such principles would apply the laws of any other jurisdiction).
6. This Agreement may not be amended, modified, altered or supplemented other than by means of a written instrument duly executed and delivered on behalf of Assignee and Assignor.
7. This Agreement may be executed and delivered by electronic mail or facsimile signature in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


