TRADEMARK ASSIGNMENT

WHEREAS, EnviroTech Pumpsystems, Inc. NOW, THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration paid to the ASSIGNOR by the ASSIGNEE, the receipt and sufficiency of which is hereby acknowledged, THE ASSIGNOR HEREBY ASSIGNS TO THE ASSIGNEE any and all right, title and interest which it may hold in and to the TRADEMARK RIGHTS, together with the goodwill of the business symbolized by and associated with the TRADEMARK RIGHTS, along with all income, royalties, and damages that are or become due or payable to ASSIGNOR with respect to the TRADEMARK RIGHTS as of the date indicated below, including monetary claims, damages and/or payments for past, present or future infringements and misappropriations of the TRADEMARK RIGHTS; and all rights to assert or sue for past, present, and future infringements and misappropriations of the TRADEMARK RIGHTS, and for the use and enjoyment of its successors and assigns, or other legal representatives.

ASSIGNOR further agrees to maintain and to promptly provide ASSIGNEE, upon its request, with all pertinent facts and documents relating to the TRADEMARK RIGHTS as may be known and accessible to ASSIGNOR and will testify as to the same in any litigation, arbitration or other proceeding related thereto, and will promptly execute and deliver to ASSIGNEE, its successors, assigns or its legal representatives, without further remuneration, any and all papers, instruments

or affidavits required to apply for, obtain, maintain, issue, record, transfer and enforce said TRADEMARK RIGHTS, which may be necessary or desirable for ASSIGNEE to fully enjoy and/or exploit any and all rights associated and/or related to the same. In the event that the assignment to ASSIGNEE of any of the TRADEMARK RIGHTS is rejected or otherwise not perfected for any reason, ASSIGNOR shall take all measures as directed by ASSIGNEE to perfect the assignment.

The ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks to issue any and all certificates of registration or certificates of renewal of the TRADEMARK RIGHTS to the ASSIGNEE as the owner of the entire interest of said TRADEMARK RIGHTS, for the sole use and benefit of the said ASSIGNEE, its successors, assigns and legal representatives.

This Assignment and Agreement shall be binding upon any and all successors of the ASSIGNOR.

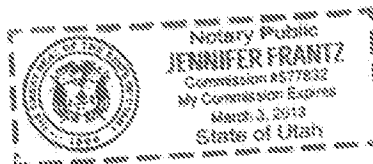
