CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION  
OF

NO EXCUSES SPORTSWEAR, LTD.

Under Section 805 of the Business Corporation Law

FIRST: The name of the corporation is No Excuses  
Sportswear, Ltd.

SECOND: The Certificate of Incorporation was filed by  
the Department of State on November 23, 1992 under the original  
name Stanrob Associates Ltd.

THIRD: The amendments to the Certificate of  
Incorporation effected by this Certificate of Amendment are as  
follows:

1. Article 1 of the Certificate of Incorporation  
is hereby amended to change the name of the Corporation  
to read in its entirety as follows:

1: The name of the corporation is  
Worldwide Apparel Resources Inc.

2. A new Article 6 is added to the Certificate of  
Incorporation providing for action by shareholders of the  
Corporation by written consent of holders of a majority  
of the outstanding shares, to read as follows:

6. Except as otherwise provided by the New  
York Business Corporation Law or otherwise required  
by law, any action that may be taken by a vote of  
the shareholders of the Corporation may be taken

without a meeting and without a vote if a consent or consents in writing setting forth the action so taken shall be signed by the holders of a majority of the outstanding shares of the Corporation entitled to vote thereon. All such consents to any such action must be executed within sixty (60) days of the date on which the first such consent is executed. Prompt notice of the taking of action without a meeting by less than unanimous written consent of shareholders shall be given to those shareholders who have not consented in writing to such action.

FOURTH: The foregoing amendment of the Certificate of Incorporation was authorized by the vote of the Board of Directors of the corporation, followed by the affirmative vote of the holders all outstanding shares entitled to vote thereon by written consent.
