TRADEMARK ASSIGNMENT

WHEREAS, Okrujnost LLC, a Russian limited liability company, at 2, Pushkin Street, Penza, Penza Region, Russian Federation 440008 ("Okrujnost") is owner of the following (collectively, the "Trademark Rights"):

U.S. Trademark Registration Nos. 4427536 and 4404557 for the marks IFUNNY; and

Any and all rights and privileges provided under the trademark, unfair competition and other laws of the United States, the individual states thereof and jurisdictions foreign thereto with respect to the marks of the foregoing registrations; the GOODWILL of the business in which the marks are used; and any and all renewals thereof, together with the right to bring suit and collect for past infringements thereof.

NOW, THEREFORE, in view of the payment of Ten Dollars (\$10.00), and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Okrujnost DOES HEREBY forever assign and transfer to Ifunny all right, title and interest in and to the Trademark Rights including, without limitation, the GOODWILL of the business in which the marks are used.

Okrujnost shall, without further consideration, execute any additional documents and take such further action as may be requested to vest in Ifunny good, valid and marketable title to the Trademark Rights. This Assignment and all terms hereof shall be binding upon and inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors and assigns.
