NUNC PRO TUNC TRADEMARK AND COPYRIGHT ASSIGNMENT

Assignor further warrants that upon request of Assignee, it shall execute all papers, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this agreement, as well as provide such other material information or assistance as Assignee may consider necessary to carry out the intent of this assignment.

This assignment shall be binding upon the parties, their successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.
