TRADEMARK ASSIGNMENT AGREEMENT

This agreement ("Agreement") is by and between JHC INTERNATIONAL, INC., a California corporation ("Assignor") on the one hand, and JHC INTERNATIONAL, INC., a California corporation, and PRIMOCYN EAU DIVINE, INC., a California corporation, (collectively the "Assignees") on the other hand, and is effective as of May 10, 2016, ("Effective Date"). Assignor and Assignees may collectively be referred to as the "Parties".

WHEREAS, Assignor is the owner of a registered trademark identified in Exhibit "A" (the "Trademark"); and

WHEREAS, Assignor desires to transfer all of its right, title and interest in and to the Trademark to Assignees;

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Trademark Assignment. Assignor irrevocably assigns, grants and transfers to Assignees, all of Assignor's right, title, and interest in and to the Trademark, including all common law rights, and any trademark registrations and applications, along with the goodwill of the business symbolized by use of the Trademark, and the right to sue third parties for and recover damages from future infringement of the Trademark, the same to be held and enjoyed by Assignees for their own use and enjoyment and the use and enjoyment of their successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made (the "Assignment").

Assignor and Assignees further agree to take all steps necessary to promptly expedite any perfection of Assignees' ownership in and to the Trademark. The Parties hereby authorize the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer said Trademark to Assignees as owners of all right, title and interest therein, or otherwise as Assignees may direct, in accordance with the terms of the Assignment.

2. Execution and Delivery. Upon Assignees' request, Assignor agrees that it will take such actions and execute such documents (including, without limitation, the prompt execution and delivery of documents in recordable form or testifying as to any material fact or thing as may be necessary to vest in and secure unto Assignees the full right, title and interest in and to the Trademark and to protect and enforce the Trademark.

3. Representations and Warranties. Assignor represents and warrants that Assignor has the full right to convey the entire right, title and interest herein assigned, and that Assignor will not take any action, use any trademark, execute any instrument, or grant or transfer any rights, title or interests inconsistent with the rights, title and interests assigned herein.

4. Limitation of Liability. IN NO EVENT SHALL ANY OF THE PARTIES BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM OR






