RECORDABLE TRADEMARK ASSIGNMENT

Assignor has sold, transferred, conveyed, assigned and delivered to Assignee the entire right, title and interest of Assignor in, to and under the following (collectively, the "Assigned Trademarks"): (a) the trademark registrations and applications listed in the attached Exhibit A, including renewal rights and any other related common law trademarks and rights; and (b) the goodwill of the business symbolized by the trademark registrations and applications listed in Exhibit A and any other related common law trademarks and rights.

2. The conveyed right, title and interest includes all past, present and future claims of infringement and/or passing off at common law for each Assigned Trademark, including the right to seek and collect past, present and future damages.

3. All rights in the Assigned Trademarks are to be held and enjoyed by Assignee, for its own use and enjoyment and for the use and enjoyment of its successors and assigns to the end of the term of any resulting trademark rights, as fully and entirely as the same would have been held and enjoyed by Assignor if the assignment described in this Assignment had not been made.

4. This Assignment may be recorded in official trademark office records.


