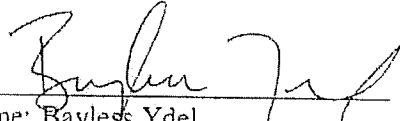
1. The name of the limited liability company is Enrollment Advisors, LLC.
