TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 20, 2016, by DEERPATH FUNDING, LP, in its capacity as administrative agent (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Northwest Investment Consulting, Inc., a Washington corporation and CDM Retirement Consultants, Inc., a Maryland corporation (collectively, the “Grantor”) and Secured Party are parties to that certain Patent and Trademark Security Agreement dated as of January 9, 2015 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Secured Party in the IP Collateral (as defined therein) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks and Patents set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on January 13, 2015, at Reel 5439, Frame 0693;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks, Patents and IP Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor’s right, title and interest in and to the following:

- (i) all of its patents, patent applications, and patent licenses to which it is a party, including but not limited to those referred to on Schedule 1 attached hereto;
- (ii) all of its trademarks, trademark applications, and any related licenses to which it is a party, including but not limited to those referred to on Schedule 1 attached hereto;
- (iii) all reissues, continuations or extensions of the foregoing; and
- (iv) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any of the foregoing.


