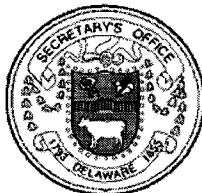

**CERTIFICATE OF AMENDMENT
OF
AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
UTAH MEDIA, INC.**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware

Utah Media, Inc. (hereinafter called the "Corporation"), organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

The name of the Corporation is "Utah Media, Inc." and it was originally incorporated under the name "Diversified Suburban Newspapers, Inc." and the Certificate of Incorporation was filed on June 11, 1984 with the Secretary of the State of Delaware. The original Certificate of Incorporation was amended on March 12, 1987, and amended and restated on December 21, 2004. The Amended and Restated Certificate of Incorporation was amended on January 26, 2005.

The Board of Directors of the Corporation, by unanimous written consent dated May 1, 2016, adopted resolutions pursuant to Section 242 of the General Corporation Law of the State of Delaware, setting forth amendments to the Certificate of Incorporation of the Corporation and declaring said amendments to be advisable. The sole stockholder of the Corporation duly approved said proposed amendments by written consent in accordance with Section 228 and 242 of the General Corporation Law of the State of Delaware. The resolutions setting forth the amendments are as follows:


RESOLVED: That Article First of the Certificate of Incorporation be, and it hereby is, deleted and the following Article First is inserted in lieu thereof:

"FIRST: The name of the corporation (hereafter called the "Corporation") is "Wasatch Mountain News Media Co."

RESOLVED: That Article Sixth of the Certificate of Incorporation is hereby amended by deleting the word "even" in the second sentence of Section 1 thereof.

IN WITNESS WHEREOF, the Corporation has caused this Certificate of Amendment to be signed by a duly authorized officer this 1st day of May, 2016.
