**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY RIGHTS**

**THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS** (this "Termination"), is dated as of May 20, 2016 and made by **OXFORD FINANCE LLC**, a Delaware limited liability company, as Collateral Agent, located at 133 North Fairfax Street, Alexandria, Virginia 22314 ("Grantee") to **KEYSTONE DENTAL, INC.**, a Delaware corporation ("Grantor"), located at 154 Middlesex Turnpike, Burlington, Massachusetts 01803.

**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement, dated as of July 29, 2011, made by Grantor in favor of Grantee (the "Security Agreement"; defined terms used herein without definition shall have the meanings assigned to them in the Security Agreement), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks and the Patents (as hereinafter defined);

**WHEREAS**, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 17, 2011, at Reel 4606 and Frame 0660, on October 28, 2011 at Reel 4650 and Frame 0932, and on June 30, 2012 at Reel 4812 and Frame 0321;

**WHEREAS**, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on August 17, 2011 at Reel 026766 and Frame 0462, and on October 28, 2011 at Reel 027140 and Frame 0693;

**WHEREAS**, the Obligations under the Loan Agreement have been indefeasibly satisfied in full, the Grantee's obligation to make Credit Extensions under the Loan Agreement have terminated, and Grantee now desires to terminate and release the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. The term "Patents," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the patents listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and the Patents and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks and the Patents.
