Assignor hereby represents, warrants and covenants: (a) that the Registration is valid, subsisting and still in force; (b) that it has taken all action necessary to authorize execution of this Assignment; (c) that this Assignment and each of its terms are binding; (d) that it has the requisite power and authority to perform the acts stated herein; (e) that the undersigned signatory has the full legal right, power and authority to bind Assignor; (f) that it has not assigned or delegated to any third party all or any part of the rights and obligations set forth herein; and (g) that it owns and has not assigned, conveyed, pledged, encumbered or otherwise transferred, in
