SHORT-FORM TRADEMARK SECURITY AGREEMENT

WHEREAS, POLYREMEDY, INC. (the "Grantor") has adopted, used, is using, or intends to use, and is the owner of the trademarks and trademark applications listed on Schedule A attached hereto, and the registrations and applications associated therewith; and

Notwithstanding the foregoing, in the event of any conflict between this Short-Form Trademark Security Agreement and the Security Agreement, the Security Agreement shall control.
