TRADEMARK ASSIGNMENT

This Trademark Assignment, effective as of January 30, 2012 ("Effective Date"), is between Concept Six LLC, a New York limited liability company located and doing business at 119 West 40th Street, New York, NY 10018 ("Assignor"), and Original Blue Marlin LLC, a New York limited liability company located and doing business at 1400 Broadway, New York, NY 10018 ("Assignee").

WHEREAS, Assignor is the record owner of all of the right, title and interest in and to the BLUE MARLIN trademarks depicted in Schedule A hereto (collectively, the "Marks"), which are the subjects of, respectively, U.S. Trademark Registration Nos. 4,068,274, 4,068,275, 4,515,063, and US Trademark Application Serial No. 86/831,584 (collectively, the "Registrations and Application"), and all of the goodwill and business associated and connected with the Marks, and desires to confirm the prior assignment, transfer and sale to Assignee of the Marks, all of the goodwill associated therewith, the portion of its business connected to the Marks and the Registrations and Application, via the Operating Agreement dated January 30, 2012; and

WHEREAS, Assignee is desirous to confirm the prior acquisition of Assignor's entire right, title and interest in and to the Marks, all of the goodwill associated therewith, the portion of Assignor's business connected with the Marks and the Registrations and Application.

NOW, THEREFORE, for One Dollar (\$1.00) and other fair and good consideration, Assignor, as of the Effective Date, hereby assigns, transfers and sells to Assignee, its successors, and assigns, Assignor's entire right, title and interest in and to the Marks, the goodwill associated therewith, the portion of Assignor's business connected with the Marks, the Registrations and Application and any and all other trademarks, service marks and trade name registrations and

applications and registrations therefor, any renewals thereof, all income, royalties, damages, and payments now or hereafter due or payable with respect to the Marks, all causes of action (in law and/or equity) and the right to sue, counterclaim, and recover for past, present, and future infringement, misappropriation, or dilution of the rights assigned to Assignee hereunder, and all rights, including the goodwill, corresponding thereto throughout the respective countries where Assignor holds rights in the Marks.

Assignor, as of the Effective Date, agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents regarding the rights assigned, transferred and sold herein, as reasonably requested by Assignee or its successors or assigns.

WHEREFORE, Assignor has duly executed this Trademark Assignment on the date indicated above.
