WHEREAS, in connection with the ABL Credit Agreement, dated as of April 12, 2012 (as amended, amended and restated, waived, supplemented, or otherwise modified from time to time, the "Credit Agreement"), HDS IP Holding, LLC and certain other grantors (each a "Grantor" and collectively the "Grantors") executed that certain ABL Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of April 12, 2012, and which was recorded in the Trademark Division of the United States Patent and Trademark Office on April 12, 2012, at Reel 4754, Frame 0861, and that certain ABL Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of December 4, 2014, and which was recorded in the Trademark Division of the United States Patent and Trademark Office on December 5, 2014, at Reel 5414, Frame 0846 (collectively, the "Notices"), pursuant to which each Grantor confirmed the grant to the Assignor of a security interest in such Grantor's trademark registrations and trademark applications.
