NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of May 18, 2016, and made by PNC Bank, National Association, in its capacity as agent for the Lenders described in the Security Agreement defined below (in such capacity, "Secured Party").

WHEREAS, reference is made to that certain Supplement to Trademark Security Agreement, dated as of April 21, 2010 between K'NEX BRANDS, L.P., a Delaware limited partnership, f/k/a CONNECTOR SET LIMITED PARTNERSHIP GROUP, a Delaware limited partnership ("K'NEX"), and K'NEX LIMITED PARTNERSHIP GROUP, a Delaware limited partnership ("Grantor") in favor of Secured Party (the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Secured Party a security interest in certain of the Grantor's assets, including, without limitation, the trademarks ("Trademarks") owned by Grantor as described in the Security Agreement; and

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on May 6, 2010 at Reel/Frame 004200/0020; and

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Secured Party hereby releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to solely the Trademarks of Grantor set forth on Exhibit A attached hereto, and hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.
