NUNC PRO TUNC TRADEMARK ASSIGNMENT

THIS NUNC PRO TUNC TRADEMARK ASSIGNMENT ("Assignment") is effective as of November 1, 2007 ("Effective Date"), between Quanex Corporation, a Delaware corporation (hereinafter "Assignor") and Quanex Homeshield, LLC, formerly Quanex Homeshield, Inc., a Delaware limited liability company having an address of 311 West Coleman Street, Rice Lake, WI 54868, which is a domestic subsidiary of Quanex Building Products Corporation (hereinafter "Assignee") (Assignor and Assignee each individually referenced as a "Party" and collectively referenced as the "Parties").

WITNESSETH

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademarks listed in SCHEDULE A attached hereto (collectively, the "Trademarks") and all associated common law, statutory and other rights and all goodwill of the business associated with or symbolized by the Trademarks;

WHEREAS, Assignor and Assignee have entered into a certain General Conveyance, Assignment, Bill of Sale and Assumption Agreement dated November 1, 2007, pursuant to which, among other things, Assignor assigned and transferred to Assignee all of its right, title and interest, including all associated common law, statutory and other rights and all associated goodwill, in and to said Trademarks; and

WHEREAS, it is the purpose of this document to memorialize the transfer of Assignor's right, title and interest, including all associated common law, statutory and other rights and all associated goodwill, in and to the Trademarks, the same to be held and enjoyed by Assignee, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by Assignor, had this assignment not been made to Assignee, in a form suitable for recording in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration for the foregoing premises, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor confirms the transfer and assignment, and does assign and transfer, *Nunc Pro Tunc*, to Assignee, all of Assignor's right, title, and interest in and to the Trademarks, and the identified registrations, together with the goodwill of the business in connection with which such Trademarks are used, and which is symbolized by such Trademarks, and any and all associated common law rights, statutory, and other rights of Assignor in such Trademarks.

Assignor further hereby unconditionally and irrevocably sells, grants, assigns, transfers and conveys, *Nunc Pro Tunc*, to Assignee all of Assignor's right, title and interest in all to all services and proceeds of the Trademarks and the goodwill of the business associated with or symbolized by the Trademarks (including, without limitation, all associated common law, statutory, and other rights in the Trademarks), asserts against any third parties for past, present, or future misappropriation or infringement of any of the foregoing or of the Trademarks or the goodwill of the business associated with, or symbolized by the Trademarks, together with the right to sue and recover the same in the Assignee's own name, to have and to hold the same for Assignee's own use and benefit

and for the benefit of Assignee's successors, assigns, and legal representatives.

Assignor agrees to execute and deliver, at the request of Assignee, all papers, instruments, and assignments necessary, and to perform any other reasonable acts Assignee may require, in order to fully vest in Assignee all of Assignor's right, title, and interest in and to the Trademarks, and all associated common law rights and goodwill.

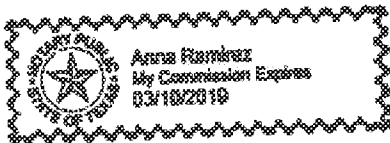

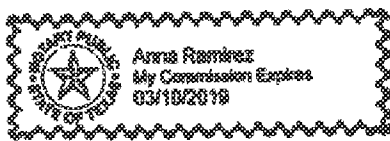

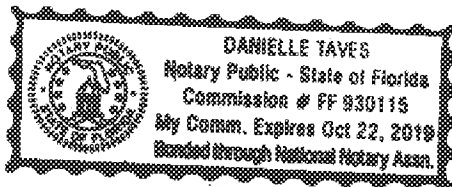
