## TRADEMARK ASSIGNMENT

This Trademark Assignment ("ASSIGNMENT") is made between BoxFox, LLC ("ASSIGNOR"), a Limited Liability Company organized and existing under the laws of the state of California with its head office located at 8734 Lindanta Drive, Whittier, California 90603, and BoxFox Inc ("ASSIGNEE"), a Delaware corporation with its head office located at 8734 Lindanta Drive, Whittier, California 90603.

WHEREAS, ASSIGNOR is the owner of U.S. Trademark Application Serial No. 86/933,125 for the BOX FOX (design) trademark, which has a filing date of March 8, 2016 ("Mark"), together with the goodwill of the business symbolized thereby in connection with the goods and services on which the Mark is used.

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Mark, and the goodwill of the business symbolized thereby in connection with the goods and services on which the Mark is used.

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE, all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Mark, together with: (1) the associated goodwill relating to the Mark and the business symbolized thereby in connection with the goods and services on which the Mark is and will be used and for which the Mark is and will be registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark and goodwill, including without limitation, damages, and payments for past or future infringements and misappropriations of the associated Mark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark and associated goodwill.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark and the associated goodwill.

If any term, provision, covenant or condition of this ASSIGNMENT, or the application thereof to any person, place or circumstance, shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this ASSIGNMENT and such terms, provisions, covenants or conditions as applied to other persons, places and circumstances shall remain in full force and effect.

This ASSIGNMENT shall be construed in accordance with, and all actions arising hereunder shall be governed by, the laws of the State of Delaware.


