**Affidavit of Marta Levine Regarding
Release of the Lien Held by Greyhound Financial Corporation**

I, Marta Levine, being first duly sworn, on oath do hereby state that:

1. I am an attorney with the law firm of Quarles & Brady LLP and a member of the State bars of Wisconsin and Illinois. I represent Universal Avionics Systems Corporation, an Arizona corporation, (the "Company") and am authorized to make this affidavit on the Company's behalf. This affidavit is based on matters I know of my own personal knowledge, as well as on information provided to me by employees of Quarles & Brady LLP and employees of the Company, who gathered such information under my direction and control from publicly available information and from books and records of the Company maintained in the ordinary course of business.

2. I make this affidavit in support of the Company's request that the lien recorded by Greyhound Financial Corporation (at Reel/Frame 1113/0233 on March 7, 1994) against trademarks owned by the Company be released on the grounds that:

- a. The underlying debt has been satisfied and the lien released under the Uniform Commercial Code and/or
- b. Greyhound Financial Corporation (or its successor in interest) no longer exists as a legal entity.

3. On February 25, 1994, the Company's predecessor in interest, Universal Navigation Corporation (a California corporation), granted a lien to Greyhound Financial Corporation in the trademarks owned by Universal Navigation Corporation listed below:

(the "Trademarks"). This lien was recorded with the US Patent and Trademark Office at Reel/Frame 1113/0233 on March 7, 1994.

A. **The underlying debt has been satisfied and the lien released under the Uniform Commercial Code.**

4. To perfect its lien in the Trademarks, Greyhound Financial Corporation was required under the Uniform Commercial Code to record its lien with the Secretary of State of the State of Arizona (where Universal Navigation Corporation was located) and/or the Secretary of State of the State of California (where Universal Navigation Corporation was incorporated). Every five years thereafter, Greyhound Financial Corporation was required under the Uniform Commercial Code to file a continuation statement with the relevant State Secretary of State, to continue its perfection in its lien in the Trademarks.

5. To the best of the Company's knowledge, on or before 2009, Universal Navigation Corporation paid off the debt it owed to Greyhound Financial Corporation or its successor in interest and the lien was released.

6. No continuation statement by Greyhound Financial Corporation or its successor in interest is currently recorded against either Universal Navigation Corporation or the Company with the Secretary of State of the State of Arizona or the Secretary of State of the State of California.

7. Accordingly, based on the Company's knowledge and the record of Uniform Commercial Code filings, it appears that the debt was paid by Universal Navigation Corporation and the lien released by Greyhound Financial Corporation or its successor in interest.

B. Greyhound Financial Corporation (or its successor in interest) no longer exists as a legal entity.

8. In 2001, Greyhound Financial Corporation and various related entities, including The Finova Group, Inc. and Finova Capital Corporation, filed voluntary petitions under Chapter 11 of the Bankruptcy Code in the Bankruptcy Court for the District of Delaware (the cases were jointly administered under Case No. 01-00698-PJW).

9. A plan of reorganization for Greyhound Financial Corporation and various related entities, including The Finova Group, Inc. and Finova Capital Corporation, was confirmed and became effective on September 10, 2001.

10. In 2005, Greyhound Financial Corporation merged into Finova Capital Corporation (a Delaware corporation).

11. On November 17, 2009, Finova Capital Corporation filed a notice of dissolution of corporate status with the Delaware Secretary of State (*see* attached Exhibit A).

12. The final decree closing the Chapter 11 cases of Greyhound Financial Corporation and various related entities, including The Finova Group, Inc. and Finova Capital Corporation, to the extent any remained in existence, was issued by the Bankruptcy Court on December 29, 2009.

13. As neither Greyhound Financial Corporation nor its successor in interest, Finova Capital Corporation, still exist, there is no longer any lien held by either of these entities.

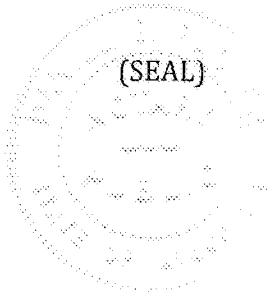
